

## **RTS Advisory has NO association with Green Machine**

Dear Shareholder,

### **RTS Advisory is NOT associated with Green Machine**

A small but significant number of shareholders has either telephoned or written to the Company advising us of approaches being made to them by a firm calling itself RTSAdvisory.com or some derivative thereof.

RTSAdvisory is **NOT** associated with Greed Machine nor is known to Green Machine.

### **More Takeover Rumours**

Takeover rumours continue to persist. We restate that there is no takeover currently on foot of which the Company or its board is aware. Your board must review any takeover offer prior to acceptance.

Your board would not consider any offers below €4.00 at this time however your board would not reject any offer without first consulting the shareholders.

Your board is charged with the responsibility of acting in the best interests of the Company and therefore all shareholders.

All shareholders must be advised prior to any takeover being accepted by the Company. All shareholders must be treated equally otherwise the takeover will fail for legal reasons.

You cannot lose your shares in a takeover. The only way your shares can be dealt with is by you and under your specific authority and signature.

### **Format of Cold Calls to shareholders by RTS Advisory**

Persons claiming to be acting for RTSAdvisory have been cold calling shareholders stating that they (RTSAdvisory) is working closely with the Company to facilitate disposal of Green Machine stock. This is **FALSE**.

RTSAdvisory has been asking shareholders for details of share certificates. If the company was working closely with RTSAdvisory they would refer to the Company for information not to shareholders.

The Company's share register is a protected document. It is not information which is in the public arena. Company share registers, whilst historically public documents, are now protected to guard against scammers and fraudsters.

Below is an email from a shareholder which illustrates the types of questions being asked:-

*Dear Sirs,*

*I have been approached by a company which claims to be working closely with you to facilitate disposal of my shareholding in your*

*company. Their advisor wanted me to give them details of my share certificates and my shareholdings and informed me that your company will not list on Euronext and is likely to be bought outright by a German institution.*

*These statements appear to conflict with the official emails I have received from yourselves in February relating to takeover rumours and a proposed flotation. Could you please indicate if you are working with this company RTSadvisory.com and need shareholders like myself to divulge personal shareholding information to them as I am conscious there are numerous scams operating and companies involved in them and I don't want to become a victim and lose my shareholding as a result.*
